As at 30 December 2022, the Company's issued share capital consisted of 1,265,377,243 ordinary shares of £0.005 each ("**Ordinary Shares**"), 56,082,651 D1 ordinary shares of £0.005 each, 17,741 D2 ordinary shares of £1.00 each, 48,995,797 E ordinary shares of £0.005 each, 27,122,287 F ordinary shares of £0.005 each, 17,494,614 G ordinary shares of £0.005 each, 1 Special Share of £1.00, 313,257 deferred 1 shares of £0.005 each and 21,563,860 deferred 2 shares of £0.005 each. The Company does not hold any shares in treasury.

Only the Ordinary Shares are voting shares and each such Ordinary Share carries one vote per Ordinary Share.

Accordingly, the total number of voting rights in the Company as at 30 December 2022 was 1,265,377,243. This figure may be used by the Company's shareholders as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change to their interest in, the Company under the Disclosure Guidance and Transparency Rules.
